Used to apply for replacement Water Entitlements Certificate, Share Statement and/or Delivery Entitlements Statement, where the original has been lost, misplaced, defaced, or destroyed.

1 Checklist

The following is a list of documents required for processing of this application:

- Form 8, duly completed
- Copy of newspaper advertisement (an example is attached to the form)
- Letter from encumbrancee certifying due search and enquiry (if applicable)
- The prescribed fee (refer to Schedule of Standard Service Charges; "Other Dealings")

Additional requirements, if any, will be advised upon receipt of application.

2 Completing the Application

- 1) Only original, current version forms will be accepted. Fax or email copies will not be processed.

- 5) Ensure the advertisement is either an original, or has been certified.
