When Share and Water Entitlements Certificates were issued to customers in 1995, some were issued with incorrect names. This application is used to for replacement Water Entitlements Certificate, Share Statement and/or Delivery Entitlements Statement in the correct name.

This application does not apply where there has been a change of ownership since March 1995.
