



## Guide to the Application : Certificate Following Reduction

On 1 July 2009, Murray Irrigation reduced customers' water entitlements by approximately 17% to remove the transmission losses component, in response to, among other things, the introduction of the *Water Market Rules 2009* (Cth).

This application is used to apply for replacement Water Entitlements Certificate following the said reduction, where no such certificate has yet been issued.
