## **Drainage into drains: Information**

Approval is required to discharge water into Murray Irrigation's drainage system.

Discharge into the drainage system is only permitted via a drainage inlet.

Discharge into the drainage system can only be commenced after approval has been received from Murray Irrigation.

It is the landholders' responsibility to close drainage inlet slides into the drainage system at the end of the approved discharge event.
